TIME LIMITS ALSO DO NOT INCLUDE POSSIBLE RETENTION TIME OF THE ITEM AT CUSTOMS.

FOR ALL COUNTRIES WHICH ARE NOT ON THE ABOVE MENTIONED LIST, LETTER-POST ITEMS ARE SENT BY MEANS OF OTHER POSTAL OPERATORS IN TRANSIT. EXPECTED TRANSFER TIME LIMITS FOR SUCH ITEMS ARE MORE THEN 5 DAYS.
