

REGULATIONS ON AMENDMENTS TO THE REGULATIONS ON GENERAL CONDITIONS FOR THE PROVISION OF PAYMENT SERVICES IN THE PUBLIC ENTERPRISE "POST OF SERBIA", BELGRADE, AS WELL AS SPECIFIC SERVICES RELATED TO PAYMENT SERVICES

## **Article 1**

In the Regulations on general conditions for the provision of payment services in the Public Enterprise "Post of Serbia", Belgrade, as well as specific services related to payment services ("Official PTT Gazette", Nos. 1293/19 and 1343/20, hereinafter: the Regulations), in Article 5, paragraph 1, item 2) is amended to read as follows:

"2) cash payments to the debit of current / savings accounts of PSB clients."

Paragraph 2 shall be deleted, and the previous paragraphs 3 and 4 become paras. 2 and 3

The previous paragraph 5, which becomes paragraph 4, is amended to read as follows:

"For services from paras. 1 and 3 of this Article, the Post does not charge a commission from the customer."

#### Article 2

In Article 15, paragraph 2 of the General Conditions, the words: "Annex 1" are replaced by the words: "Annex 1a" and the words: "Annex 2" are replaced by the words: "Annex 2a".

## Article 3

Annex 1 and Annex 2 are replaced by Annex 1a and Annex 2a, which form an integral part of these General Conditions.

#### Article 4

These Regulations shall enter into force on the day following the day of their publication in the "Official PTT Gazette", and shall be applied as of February 18, 2021.
