For postal items weighing above 0.5 kg, a value price is added to the sales prices in the table: - for every 65 SDR or a part of 65 SDR of insured value	200,00

- Postal items weighing up to 0.5 kg are accepted as tracked postal items, including postage for submitting postal items for customs inspection at export.
- Postal items weighing above 0.5 kg are accepted as parcels with insured value, including postage for submitting the parcel for export customs inspection.
- The "POST EXPORT - EXPORT OF GOODS" service, upon special request of users for submitting an offer - contract prices, is applied in cases where the Company, upon invitation to submit an offer, submits an offer for participation in the procurement procedures of services that involve deviation from standard/usual technological procedures and activities and respect for the cost principle

SDR is a unit of accounting in international postal traffic, 1 SDR = 142.0367 RSD.
