Change or correction of the recipient's address	200.00 (if the request is to be sent by telegram, the sender also pays the price of the telegram)
Return of postal item before delivery	200.00 (if the request is to be sent by telegram, the sender also pays the price of the telegram)
Return of return receipt for registered postal items	180.00
Issuance of additional confirmation of receipt of registered postal items	50.00
Handling separate (fragile) parcels	50% of the basic price and price according to weight of the parcel
Handling bulky parcels	50% of the basic price and price according to weight of the parcel
Paid reply in international traffic (IBRS)	According to contract
Redirection of a registered postal item to a new address, including <i>poste-restante</i>	200.00

Storing of registered postal items in post office outside of prescribed time limits, but no longer than 30 days	90.00
Redirection of a postal item to a new address, including <i>poste-restante</i>	300.00
Re-delivery of parcels	120.00
Delivery of <i>poste-restante</i> items at the address	85.00
Personal delivery of registered postal items	60.00
Issuance of confirmation or a certified copy of postal document relating to the delivery of a registered item	50.00

Service	Price
Return of non-delivered postal items to the sender	For the return of a non-delivered parcel, postage is charged in accordance with international regulations
Receipt and recording of authorisations	70.00
Re-packing of items with damaged content, reporting on items' irregularities and notifying the customer	60.00 (price of wrapping material is additionally charged, in case the material is used)
Storing of items for delivery, in accordance with the time limits set by the general conditions, for parcels (storage fee) – per day	20.00
